### **VOLUNTEER WORK**

Players receiving financial aid and their families are required to exert a maximum effort to do volunteer work. This volunteer time may consist of, but is not limited to, lining fields, managing a team, fundraising, etc. Additionally, there is a commitment from the player to attend all practices and games, unless excused by the coach, and to maintain a positive attitude throughout the season. Failure to fulfill the above requirements may result in review of the financial aid granted and possible ineligibility from participating in any team training or games.

All financial aid applicants are expected to pay the reduced player fees on the same payment schedule as other players unless otherwise approved by the Financial Aid Committee.

Please know that all information requested will be kept completely confidential. Award decisions will be made by the FA Committee and you will be notified soon thereafter if your completed application is turned in.

## Financial Aid Program

### Who can apply?

Any CCU members

### When can you apply?

At the time of registration each year

### How does it work?

Step 1: Complete financial aid application – found on club website (or ask your coach)

Step 2: Return your completed financial aid application + prior years' tax returns back to the DOO.

Step 3: The DOO will meet with the Financial Aid Committee. They will review your application and determine eligibility.

### How is Financial Aid awarded?

Priority is given to those that complete the applicable paperwork. Applications are means tested and awarded based on need. Aid is awarded up to 50% of annual dues.

### When will we find out if we qualify?

The DOO will notify you immediately after they meet with the financial aid committee. You will also receive a letter in the mail.

### How do you means test applications?

Central Coast United uses the US Department of Housing & Urban Development (HUD) for San Luis Obispo County.
